a tributary of North Fork Coquille River irrigation of 20.3 acres

for the purpose of

under Permit No. and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 9, 1947 that the amount of water to which such right is entitled and hereby confirmed, for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foo+ per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, NW4 SE4, Section 11, T. 28 S., R. 10 W., W. M., No. 1-960 feet South and 900 feet Nest; No. 2-1780 feet South and 1700 feet West, both from the NE Corner, SE% NE%, Section 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right 10.6 acres SE% NE% is appurtenant, is as follows:

4.5 acres SW4 NE4 5.2 acres NW4 SE4

All land between the county road and the East Fork of the Coquille River in the St of the NE% excepting the East 150 feet; all land between the county road and the East Fork of the Coquille River in the NW4 of the SE4, Section 11, T. 28 S., R.~10 W., W. M. This certificate is issued to supersede certificate of water right recorded on

page 21656, Volume 16, State Record of Water Right Certificates, so as to correctly locate the points of diversion. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
