## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** FORREST SOLOMON

of 33662 E. Park Drive, Creswell, State of Oregon, 97426, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Umpqua River

a tributary of Pacific Ocean for the purpose of irrigation of 60.0 acres

under Permit No. 38166 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Chadwick DLC 58, Section 18, T. 22 S., R. 8 W., W. M., 50 feet South and 400 feet West from the N $\frac{1}{2}$  corner of Section 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.3 acres Lot 3 (SW $\frac{1}{2}$  NW $\frac{1}{2}$ )  
2.7 acres Lot 4 (SE $\frac{1}{2}$  NW $\frac{1}{2}$ )  
10.6 acres SE $\frac{1}{2}$  NW $\frac{1}{2}$   
As projected within Chadwick DLC 58  
Section 18

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
