CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEORGE T. THOMPSON

of Drain _____, State of Oregon, 97435, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Elk Creek

a tributary of Umpqua River _____ for the purpose of irrigation of 12.7 acres

under Permit No. 20068 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 9, 1951 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Putnam DLC 39, Section 15, T. 22 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

All as projected within Putnam DLC 39

Land on which water is to be used is part of that described as follows:

Beginning at a point South 1 degree 25 minutes West 863 feet from the NW Corner of Christian DLC 41; thence South 1 degree 25 minutes West 816.2 feet; thence North 45 degrees 8 minutes West 232.6 feet North 40 degrees 30 minutes 3 seconds West 257.7 feet, North 59 degrees 5 minutes 30 seconds West 64.6 feet, North 29 degrees 2 minutes 30 seconds West 382.2 feet, North 55 degrees 40 minutes West 220.5 feet and North 72 degrees 34 minutes 30 seconds West 176.2 feet along creek bank thence North 10 degrees 02 minutes East 470.6 feet to South right of-way of Highway 38; thence South 72 degrees 33 minutes 30 seconds East 482.2 feet; thence South 16 degrees 44 minutes West 226.88 feet; thence South 74 degrees 46 minutes East 267.3 feet; thence South 0 degrees 17 minutes East 107.1 feet; thence South 86 degrees 29 minutes East 208.7 feet to the place of beginning all in Section 15, Township 22 South, Range 6 West, W.M.

This certificate is issued to supersede certificate of water right recorded on page 22028, Volume 16, State Record of Water Right Certificates so as to correctly locate the point of diversion and place of use.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
