of Box 75, Little Butte Star Rt., Eagle Point, State of Oregon, 97524, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Knutzen Gulch and reservoir constructed under Permit No. R-1221

a tributary of Little Butte Creek irrigation of 30.0 acres

for the purpose of

under Permit No. 20559 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 13, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.375 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 32, T. 35 S., R. 1 E., W. M., Stream-30 feet South and 550 feet West; Reservoir-480 feet South and 2790 feet West, both from the E $\frac{1}{4}$ Corner, Section 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1221

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
