of 4905 Lack Road, Brawley , State of California, 92227, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Brimstone Gulch Creek, Little Brimstone Creek, & Ehlig Reservoir constructed under Permit No. R-5504 a tributary of Grave Creek for the purpose of

under Permit No. 34563 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 30, 1969 for 0.08 c.f.s. from Brimstone Gulch Creek and September 22, 1969 *

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an a nount actually beneficially used for said purposes, and shall not exceed 0.11 cubic foot per second, being 0.08 c.f.s. for irrigation from Brimstone Gulch Creek and 0.03 c.f.s. for fish culture from Little Brimstone Creek & Reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE¼ NW¼; SE¼ NW¼; Section 8, T. 34 S., R. 6 W., W. M., Brimstone Gulch Creek - 170 feet South and 1300 feet West; Little Brimstore Creek - 2530 feet South and 1230 feet West; both from the N¼ Corner of Section 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
