## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** BICE DAIRY CORPORATION

of 555 N. Greenwood Rd., Rickreall, State of Oregon, 97371, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mud Slough

a tributary of Rickreall Creek for the purpose of irrigation of 75.2 acres

under Permit No. 37979 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 16, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.94 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 21, T. 7 S., R. 4 W., W. M., 650 feet South and 1650 feet West from the NW Corner, Allen DLC 50

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


