CERTIFICATE OF WATER RIGHT

This Is to Certify, That ESTATE OF VERNA M. PROBST

c/o Weldon D. Probst
of Rt. 1, Box 111E, Philomath, State of Oregon, 97370, has made
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
an unnamed stream and Bonner Creek

a tributary of Luckiamute River for the purpose of
domestic use for one family and irrigation of 0.8 acre

under Permit No. 38839 and that said right to the use of said waters has been perfected in
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from
October 30, 1973
that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.015 cubic foot per second, being 0.005 c.f.s. from unnamed stream for domestic
and 0.01 c.f.s. from Bonner Creek for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the Unnamed Stream - Lot 5 (SE $\frac{1}{4}$ NW $\frac{1}{4}$); Bonner Creek-
NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Van Peer DLC 41, Section 30, T. 10 S., R. 6 W.,
W. M., Unnamed Stream -850 feet North and 3020 feet West; Bonner Creek -1030
feet North and 1810 feet West; both from the NW Corner, Watson DLC 40

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated
during the irrigation season of each year,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right
is appurtenant, is as follows:

0.5 acre NW $\frac{1}{4}$ NE $\frac{1}{4}$
Domestic & 0.3 acre NE $\frac{1}{4}$ NW $\frac{1}{4}$
Both as projected within Van Peer DLC 41
Section 30
T. 10 S., R. 6 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place
of use herein described and is subject to the existing minimum flow policies established by the
Water Policy Review Board.
