## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** M. AND VERNA SEWALD

of Bonanza, State of Oregon, 97623, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of one well

a tributary of Lost River for the purpose of irrigation of 141.2 acres

under Permit No. U-368 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 26, 1951 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.77 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 21, T. 39 S., R. 11 E., W. M., South 03 degrees 21 minutes West 2326.7 feet from the NE Corner, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate is issued to supersede certificate of water right recorded on page 27656, Volume 19, State Record of Water Right Certificates, so as to correct the date of priority.
