CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Campwood Rt., Prescott , State of Arizona, 86301 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Malheur River

a tributary of Snake River supplemental irrigation of 86.1 acres

for the purpose of

under Permit No. 37152 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 10, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.15 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 23, T. 20 S.,R. 41 E., W. M., 1000 feet South and 880 feet East from the NW Corner, NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 23

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands. shall be limited toone-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be subject to the terms and conditions of an agreement between the Vale-Oregon and Warm Springs Irrigation Districts and the applicant recorded in the Miscellaneous Records of the Water Resources Department and by reference made a part hereof and the appropriation will be further limited to the period when water can be beneficially used prior to the * and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
