CERTIFICATE OF WATER RIGHT

This Is to Certify, That CITY OF PENDLETON

of P.O. Box 397, Pendleton, State of Oregon, 97801, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of S.W. 21st St. Well

a tributary of Umatilla River for the purpose of municipal

under Permit No. G-2202 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 16, 1962 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.2 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 10, T. 2 N., R. 32 E., W. M., 600 feet North and 920 feet East from the SW Corner, Section 10

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


