CERTIFICATE OF WATER RIGHT

This Is to Certify, That STUBBLEFIELD DITCH COMPANY

of Enterprise, State of Oregon, 97828, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Hurricane Creek

a tributary of Wallowa River for the purpose of the irrigation of 159.4 acres, domestic and stock use

under Permit No. 3279 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 10, 1917 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.12 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

NOTE: (The right hereby confirmed for 30 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 11, T. 2 S., R. 44 E., W. M., is supplemental to rights heretofore acquired from Wallowa River and Little Hurricane Creek.)

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
