under Permit No. and that said right to the use of said waters has been perfected in 38519 accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.81 cubic foot per second, being 0.80 c.f.s. from Wilson Creek for irrigation and 0.01 c.f.s. from unnamed stream for dairy

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Unnamed Stream-SE1 SW1; Wilson Creek-SW1 SE1, Section 29, T. 26 S., R. 12 W., W. M.; Unnamed Stream-2390 feet North and 230 feet East; Wilson Creek-1380 feet North and 1500 feet East, both from the SW Corner, NE4 NW4, Section 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 0.2 acre Lot 4 (SW4 NE4)
