CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDWARD J. WAGEMAN

of Rt. 4, Box 930, Roseburg, State of Oregon, 97470, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Hidden Valley Reservoir constructed under Permit No. R-5427

a tributary of Ten Mile Creek for the purpose of supplemental irrigation of 45.0 acres

under Permit No. 34136 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 28, 1969 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 50.0 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 25, T. 28 S., R. 8 W., W. M., 90 feet North and 1380 feet West from the NE Corner, Lathrop DLC 37

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~of one cubic foot per second per acre~~, a diversion of 2 $\frac{1}{2}$ acre feet for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


2.5 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
 2.7 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
 13.2 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
 23.1 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$

All as projected within Lathrop DLC 37
 0.7 acre Lot 1 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
 Section 25
 2.8 acres Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$)
 Section 36
 T. 28 S., R. 8 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
