a tributary of South Umpqua River irrigation of 56.2 acres

for the purpose of

under Permit No. 16603 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 25, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.70 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SE4, & SW4 SE4, both as projected within J. Fisher DLC 41, Section 4, T. 29 S., R. 7 W., W. M., No. 1-1950 feet North and 850 feet East, No. 2-1250 feet North and 350 feet East, both from the S4 Corner, Section 4

The amount of water used for irrigation, together with the amount secured under any oright existing for the same lands, shall be limited to one-eightieth of one cubic foot per seconper acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
