CERTIFICATE OF WATER RIGHT

This Is to Certify, That MT. VERNON IRRIGATION & POWER COMPANY

of Mt. Vernon, State of Oregon, 97865, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of John Day River and Beach Creek

a tributary of Columbia River for the purpose of irrigation of 484.77 acres and domestic use

under Permit No. E-88 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 6, 1911

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 6.16 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 25, SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 21, T. 13 S., R. 30 E., W. M. River-South 72 degrees East 2705 feet from the NW Corner Section 25; Creek (Panama Ditch)-South 31 degrees West, 2244 feet from the NE Corner, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:



The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
