CERTIFICATE OF WATER RIGHT

This Is to Certify, That HEIRS OF NICHOLAS YOUNG

of Eagle Point, State of Oregon, 97524, has
a right to the use of the waters of Little Butte Creeka tributary of Rogue River for the purpose of
irrigation of 34.5 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 14, at page 498; that the priority of the right thereby confirmed dates from 1899

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.72 cubic foot per second, measured at the head of the ditch or the point where the same leaves the natural stream, from April 1st to October 1st of each year,

The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 3, SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, NW $\frac{1}{4}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 9, T. 36 S., R. 1 W., W. M., 540 feet North and 817 feet East from the SW Corner, Section 3, 150 feet North and 1180 feet West from the SE Corner, Section 4, 85 feet South and 1095 feet East from the S $\frac{1}{2}$ Corner, *
A description of the place of use under the right, and to which such right is appurtenant, is as follows:

4.7 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 39591, Volume 31, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on March 16, 1978, approving transfer application No. 3861.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
