under Permit No. and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 4, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.73 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Diversion A-NW4 NW4, as projected within Beckner DLC 45; Diversion B-SE4 NW4, Diversion C-NE4 SW4, both as projected within Taylor DLC 48, Section 9, T. 21 S., R. 3 W., W. M.; Diversion A-280 feet North and 2020 feet West; Diversion B-920 feet South and 1390 feet West; Diversion C-1870 feet South and 1080 feet West, all from the NE Corner, *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to One-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,
