a tributary of Pudding River irrigation of 81.8 acres

for the purpose of

under Permit No. G-5708 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 1, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.02 cubic feet per second, being 0.87 c.f.s. from the South Well and 0.15 c.f.s. from the North Well

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the North Well-NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Brook DLC 64, Section 19; South Well-Lot 2 (SW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 19, T. 6 S., R. 2 W., W. M., North Well: 1040 feet North and 1230 feet East, South Well: 560 feet South and 10 feet West, both from the SW Corner, Brooks DLC 64

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
