## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DAVID S. BLAIR

of Route 1, Box 100, Rogue River , State of Oregon, 97537 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mays Creek & reservoir constructed under Permit R-872

a tributary of Evans Creek for the purpose of irrigation of 23.5 acres & supplemental irrigation of 22.5 acres

under Permit No. 17593 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 6, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.575 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NW4, Section 32, T. 34 S., R. 3 W., W. M., 35 feet North and 1675 feet East from the W4 Corner, Section 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year from direct flow and storage from reservoir constructed under Permit No. R-872,

and shall

conform to such reasonable rotation system - ay be ordered by the proper state officer.

A description of the place of use under ne right hereby confirmed, and to which such right is appurtenant, is as follows:

Primary

Supplemental 20.5 acres NE4 NW4 2.0 acres NW4 NW4 Section 5 T. 35 S., R. 3 W., W. M. 6.5 acres SE½ SW½ Section 32 T. 34 S., R. 3 W., W. M.

17.0 acres SW4 NW4 Section 5 T. 35 S., R. 3 W., W. M.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at Page 19597, Volume 14, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on July 20, 1978, approving transfer application No. 3121. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
