CERTIFICATE OF WATER RIGHT

This Is to Certify, That HEMEN - WAY FARMS

of 80254 Sears Rd., Cottage Grove, State of Oregon, 97424, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Giddings Creek

a tributary of Willamette River for the purpose of irrigation of 43.0 acres

under Permu. No. 36007 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 2, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.54 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the No. 1-SE $\frac{1}{4}$ NW $\frac{1}{4}$; No. 2-NE $\frac{1}{4}$ SW $\frac{1}{4}$, both as projected within Southwell DLC 46, Section 11, T. 20 S., R. 3 W., W. M., No. 1-350 feet South and 1140 feet West; No. 2-1480 feet South and 1700 feet West, both from the SE Corner, Clarke DLC 47

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

As projected within Southwell DLC 46
1.0 acre SE $\frac{1}{4}$ NW $\frac{1}{4}$
As projected within Clarke DLC 47
2.6 acres Lot 3 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
6.7 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
17.7 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
1.9 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
2.8 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
5.9 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
All as projected within Southwell DLC 46
