of Route 3, Box 743, Junction City , State of Oregon, 97448 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Willamette River irrigation of 135.2 acres

for the purpose of

under Permit No. G-5099 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 14. 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.69 cubic feet per second, being 0.76 c.f.s. from North Well and 0.93 c.f.s. from South Well

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (NE $\frac{1}{4}$ NE $\frac{1}{4}$), SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 35, T. 13 S., R. 5 W., W. M., North Well-420 feet South and 3530 feet East, South Well-1610 feet South and 3130 feet East, both from the NW Corner of Lot 1 (NW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 35

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

North Well

24.4 acres Lot 7 (NE¼ NE¼)
24.4 acres Lot 6 (NW¼ NE¼)
0.6 acre SW¼ NE¼
1.8 acres SE¼ NE¼
