of 660 Kincaid Rd., Williams , State of Oregon, 97544 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed stream, a spring, a spring area and reservoirs No. 1 and No. 2 constructed under Permit No. R-5989 a tributary of China Creek for the purpose of

fish culture, recreation and irrigation of 6.5 acres

under Permit No. 36896 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 8, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second, being 0.02 c.f.s. from unnamed stream, spring area and reservoir No. 2 for fish culture and recreation and 0.01 c.f.s. from spring 0.04 c.f.s. from spring area and reservoir No. 1 and 0.03 c.f.s. from unnamed *

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE½ SW½, Section 33, T. 38 S., R. 5 W., W. M., unnamed stream-700 feet North and 70 feet West; spring-520 feet North and 360 feet West; spring area-620 feet North and 130 feet West; Reservoir No. 1-480 feet North and 300 feet West; Reservoir No. 2-150 feet North and 75 feet West, all from the S½ Corner, Section 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5989.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Fish, Recreation & 6.5 acres SE¼ SW¼ Section 33

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
