CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN A. & CARLA L. HENTZE

of 500 Dane Lane, Junction City, State of Oregon, 97448, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three wells

a tributary of Willamette River for the purpose of irrigation of 83.4 acres

under Permit No. G-5768 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 19, 1973 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.05 cubic feet per second, being 0.21 c.f.s. from No. 1, 0.14 c.f.s. from No. 2, and 0.70 c.f.s. from No. 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4 & NW 1/4 NW 1/4, Section 16, T. 15 S., R. 4 W., W. M., No. 1-1920 feet South and 20 feet East; No. 2-1430 feet South and 900 feet East; No. 3-740 feet East, all from the NW Corner, Section 16, T. 15 S., R. 4 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
