CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ARTHUR G. JAGER

of 465 River Rd., Junction City, State of Oregon, 97448, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells No. 1 & No. 4

a tributary of Willamette River for the purpose of irrigation of 1.7 acres and supplemental irrigation of 34.0 acres

under Permit No. G-5782 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 3, 1973 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second, being 0.02 c.f.s. from Well No. 1 for irrigation and 0.43 c.f.s. from Well No. 4 for supplemental irrigation.

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 33, T. 15 S., R. 4 W., W. M., No. 1-1260 feet North and 800 feet East; No. 4-1240 feet North and 1580 feet East, both from the SW Corner, Section 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
