under Permit No. G-5782 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 3, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second, being 0.02 c.f.s. from Well No. 1 for irrigation and 0.43 c.f.s. from Well No. 4 for supplemental irrigation.

conform to such reasonable rotation system as may be ordered by the proper state officer.
