CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLARENCE BARRETT, JR.

of 91060 Nelson Mt. Rd., Greenleaf, State of Oregon, 97445, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Liebre Creek and unnamed creek

a tributary of Nelson Creek for the purpose of domestic use for one family and irrigation of 8.2 acres

under Permit No. 36248 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 9, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.115 cubic foot per second, being 0.005 c.f.s. from unnamed creek for domestic use, 0.01 c.f.s. from unnamed creek for irrigation and 0.10 c.f.s. from Liebre Creek for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 14, T. 17 S., R. 8 W., W. M., unnamed creek-940 feet South and 850 feet East, Liebre Creek-230 feet North and 1010 feet East, both from the W $\frac{1}{4}$ Corner, Section 14

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:



5.5 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
2.2 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$

Unnamed Creek
0.5 acre SW $\frac{1}{4}$ NW $\frac{1}{4}$
Domestic NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 14
T. 17 S., R. 8 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
