## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

HILBERT-SIM FARMS, INC.

of 29185 Blueberry Rd., Halsey, State of Oregon, 97348, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River and Lake Creek

a tributary of Columbia River  
irrigation of 340.8 acres

for the purpose of

under Permit No. 34234 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 17, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.26 cubic feet per second, being 3.39 c.f.s. from the Willamette River and 0.87 c.f.s. from Lake Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ), SE $\frac{1}{2}$  SE $\frac{1}{2}$ , as projected within Dill DLC 44, Section 18, NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within R. Watts DLC 43, Section 20, T. 13 S., R. 4 W., W. M.; Willamette River: No. 1-4050 feet North and 770 feet West; No. 2-3850 feet North and 380 feet East; No. 3-3250 feet North and 80 feet East; Lake Creek: No. 4-200 feet South and 2650 feet East, all \*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


