of 25900 Old Holley Rd., Sweet Home , State of Oregon, 97386 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two unnamed creeks and three ponds constructed under Permit No. R-6365

a tributary of Calapooia River irrigation of 30.0 acres

for the purpose of

under Permit No. 39613 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 4, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.37 cubic foot per second, being 0.21 cubic foot per second from Creek No. 1, Ponds No. 1 and No. 2, 0.16 cubic foot per second from Creek No. 2 and Pond No. 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{2}$ NW $\frac{1}{2}$, Section 14, T. 14 S., R. 1 W., W. M., Pond No. 1-530 feet South and 680 feet West, Pond No. 2-800 feet South and 660 feet West, Pond No. 3-1170 feet South and 1260 feet West, Off channel diversion for Pond No. 3-750 feet South and 1220 feet West all from N $\frac{1}{2}$ Corner, Section 14

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from ponds constructed under Permit No. R-6365

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
