a tributary of Lake Labish irrigation of 58.8 acres

for the purpose of

under Permit No. G-6213 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 10. 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.73 cubic foot per second, being 0.06 c.f.s. from Well No. 1 and 0.67 c.f.s. from Well No. 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Lot 3 (NE $\frac{1}{4}$ NN $\frac{1}{4}$), Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$), Section 16, T. 6 S., R. 2 W., W. M., No. 1-230 feet South and 2760 feet West; No. 2-400 feet South and 340 feet West, both from the NE Corner, Section 16

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
