of Rt. 1, Box 147-A, Amity , State of Oregon, 97101 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two unnamed streams, and Fast Reservoir constructed under Permit No. R-6457

a tributary of Salt Creek supplemental irrigation of 103.4 acres

for the purpose of

under Permit No. 40443 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 12, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.31 cubic feet per second, being 1.29 c.f.s. for irrigation and 0.02 c.f.s. for stock

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN $\frac{1}{4}$, as projected within Riggs DLC 56, Section 31, T. 6 S., R. 5 W., W. M., 450 feet South and 50 feet East from the N $\frac{1}{4}$ Corner, Section 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-6457

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
