Grande Ronde River, tributary of Snake River appropriated under Permit No.
37330

for the purposes of
supplemental irrigation
under Reservoir Permit No. R-6059, and that said right to store said waters has been
perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed
dates from November 26, 1973

that the amount of water entitled to be stored each year under such right, for the purposes afore-
said, shall not exceed 298.0 acre feet


