and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at page 183-*; that the priority of the right thereby confirmed dates from 1907 for Tract No. 1; 1887 for Tract No. 2; 1893 for Tract No. 3

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed $1\frac{1}{2}$ acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

The point of diversion is located in the SE4 NW4, Section 22, T. 1 N., R. 42 E., W. M., (City of Wallowa Ditch); SE4 SW4, Section 15, T. 1 S., R. 43 E., W. M.; Wood Boatman Ditch-950 feet North and 2365 feet East from the SW Corner, Section 15
