CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN E. MYERS

of 4425 Hilsinger Rd., Medford, State of Oregon, 97501, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Applegate River

a tributary of Rogue River for the purpose of irrigation of 22.0 acres

under Permit No. 23331 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 30, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second

its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Long DLC 39, Section 30, T. 38 S., R. 3 W., W. M., Kubli Ditch-2510 feet South and 3370 feet West from the NE Corner, Long DLC 39

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from April 2 to October 31 of each year; and shall be further limited to the terms and conditions of stipulation recorded on Page 913, Volume 3, Miscellaneous Records of the Water Resources Department and by reference made a part hereof.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


2.9 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
3.5 acres SW $\frac{1}{2}$ SE $\frac{1}{4}$
15.6 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered February 15, 1966 and supersedes certificate of water right recorded on Page 21512, Volume 15, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
