CERTIFICATE OF WATER RIGHT

This Is to Certify, That

D. W. & VERNA RUTHERFORD

of 57 Hawthorne Ave., Bend, State of Oregon, 97701, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Crabtree Creek

a tributary of South Santiam River for the purpose of irrigation of 16.7 acres

under Permit No. 22286 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 25, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 21, T. 11 S., R. 1 E., W. M., 1250 feet North and 700 feet West from the SE Corner, NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 21; NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, T. 11 S., R. 1 E., W. M., North 13 minutes East 1284 feet from the SE Corner, NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.7 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$

6.2 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$

7.8 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$



This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 24754, Volume 17, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on July 5, 1968 NOR modified by the provisions of an order of the Water Resources Director entered on February 10, 1969. It does confirm a change in place of use and point of diversion approved by the latter order and supersedes certificate 24754. The issuance of this superseding certificate does not confirm the status of the water right appurtenant to the lands not involved in the proceeding in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
