CERTIFICATE OF WATER RIGHT

This Is to Certify, That EUGENE C. & FRANCES MCINTYRE

of P. O. Box 193, North Powder, State of Oregon, 97867, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wolf Creek and North Powder River

a tributary of Powder River for the purpose of irrigation of 24.7 acres and supplemental irrigation of 44.1 acres

under Permit No. 35435 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 27, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.72 cubic feet per second, being 1.06 c.f.s. from Wolf Creek and 0.66 c.f.s. from Powder River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 16, T. 6 S., R. 39 E., W. M., NW 1/4 SW 1/4, Section 36, T. 6 S., R. 38 E., W. M., Wolf Creek-2260 feet South and 400 feet East from the NW Corner, Section 16; North Powder River-1470 feet South and 370 feet East from the NE Corner, SE 1/4 NE 1/4, Section 35

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
