CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MAUDE R. CALDWELL

of 208 East 8th, The Dalles, State of Oregon, 97058, has
a right to the use of the waters of Fifteen Mile Creek

a tributary of Columbia River for the purpose of
the irrigation of 29.1 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wasco County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at page 406; that the priority of the right thereby confirmed dates from 1869 for Tract No. 1 and 1907 for Tract No. 2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3 acre feet per acre in any irrigation season

The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 26, T. 2 N., R. 14 E., W. M., 20 feet South and 3010 feet West, 500 feet South and 4130 feet West, both from the E $\frac{1}{2}$ Corner, Section 26

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

7.1 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
11.4 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$

Tract No. 2
6.7 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
1.9 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
2.0 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 26
T. 2 N., R. 14 E., W. M.


This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 30, 1968 and together with certificate of water right recorded on Page 46635, Volume 39, State Record of Water Right Certificates, supersedes certificate of water right recorded on Page 5609, Volume 6, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
