CERTIFICATE OF WATER RIGHT

This Is to Certify, That MEDFORD CORPORATION

of North Pacific Hwy., Medford, State of Oregon, 97501, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Fork Little Butte Creek, Antelope Creek, Dry Creek, an unnamed stream and Medco Industrial Pond No. 3 constructed under Permit No. R-1937 a tributary of Rogue River for the purpose of maintenance of a log pond

under Permit No. 24500 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 15, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.53 cubic foot per second, being 0.53 c.f.s. from North Fork Little Butte Creek during the irrigation season and not to exceed 0.53 c.f.s. from Antelope Creek or Dry Creek and not to exceed 0.2 c.f.s. from unnamed stream during the non-** or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 20, T. 36 S., R. 2 E., W. M.; SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 30, T. 36 S., R. 1 E., W. M.; NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 24, T. 36 S., R. 1 W., W. M.; NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 6, T. 37 S., R. 1 W., W. M.; North Fork Little Butte Creek-70 feet North and 530 feet West from the E $\frac{1}{4}$ Corner, Section 20; Antelope Creek-40 feet North and 1450 feet West from the E $\frac{1}{4}$ Corner, Section 30;*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to -----of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
