## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

A. DAVID & PEGGY S. CHILDS

of Star Route, Arlington , State of Oregon, 97812 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Rock Creek for the purpose of irrigation of 86.6 acres and supplemental irrigation of 144.9 acres

under Permit No. G-4051 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 5, 1968

that the amount of water to which such right is crititled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW100 Section 30, T. 1 N., R. 21 E., W. M., 100 feet South and 100 feet East from the Center, Section 30

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
