a tributary of Malheur Lake 'or the purpose of irrigation of 287.3 acres and supplemental irrigation of 48.2 acres

under Permit No. G-5240 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 10, 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.01 cubic feet per second, being 0.71 c.f.s. from old well and 3.3 c.f.s. from new well

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW4 SE4, NE4 SE4, Section 13, T. 26 S., R. 33 E., W. M., New-2490 feet North and 1370 feet West; Old-2490 feet North and 100 feet West, both from the SE Corner, Section 13

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
