## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

OASIS LODGE NO. 41 I. O. O. F. CEMETERY

of P.O. Box 2634, Eugene , State of Oregon, 97402 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Bear Creek, Long Tom River and Fern Ridge Reservoir constructed under Permit No. R-1625 with any deficiency in the available supply from Bear Creek to be made\* a tributary of Willamette River for the purpose of irrigation of 14.97 acres

under Permit No. 32458 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 23, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 SW4, Section 34, T. 15 S., R. 5 W., W. M., River and Creek-2020 feet North and 370 feet West from the S½ Corner, Section 34, Reservoir-NE4 SW4, Section 4, T. 17 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1625, and is subject to the terms and conditions of contract No. 14-06-100-5926 or a satisfactory replacement between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.27 acres SW4 NW4 2.60 acres SE4 NW4 1.90 acres NE4 SW4 5.20 acres NW4 SW4 Section 34 T. 15 S., R. 5 W., W. M.

\*up by appropriation from Long Tom River and Fern Ridge Reservoir provided the total quantity diverted from all sources shall not exceed 0.19 c.f.s.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
