CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. A. WEST AND SONS

of Arlington, State of Oregon, 97812, has
a right to the use of the waters of Rock Creek

a tributary of John Day River for the purpose of
the irrigation of 69.6 acres, domestic and stock

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Grant County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461; that the priority of the right thereby confirmed dates from 1894

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 cubic foot per second per acre irrigated to June 1 and 1/80 cubic foot per second per acre thereafter; further limited to one acre foot per calendar month + June 1 and four acre feet per acre during season April 1 to September 30, measured at point of diversion

The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 24, T. 1 N., R. 20 E., W. M., 170 feet North and 90 feet West from the SW Corner, NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 24

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered January 3, 1977 and supersedes certificate of water right recorded on Page 25989, Volume 17, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
