## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PAUL N. GIBSON

of Box 245, Siletz , State of Oregon, 97380 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mill Creek ard Siletz River

a tributary of Pacific Ocean irrigation of 105.4 acres

for the purpose of

under Permit No. 36424 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 5, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 cubic foot per second, being 0.23 c.f.s. from Mill Creek and 0.77 c.f.s. from Siletz River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 ( $W_2$  NW4 NE4), Lot 10 ( $E_2$  SW4 NW4) and Lot 11 ( $W_2$  SE4 NW4), Section 33, T. 9 S., R. 9 W., W. M., Mill Creek-760 feet South and 2720 feet East; Siletz River-1880 feet South and 840 feet East and 2280 feet South and 1340 feet East, all from the NW Corner, Section 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
