## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JAMES H. PETERS

of 13030 Elkins Rd., Monmouth , State of Oregon, 97361 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Big Luckiamute River and Little Luckiamute River

a tributary of Willamette River for the purpose of irrigation of 50.6 acres and supplemental irrigation of 75.0 acres

under Permit No. 37574 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon: that the priority of the right hereby confirmed dates from December 22, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.96 cubic foot per second, being 0.48 c.f.s. from Big Luckimute River and 0.48 c.f.s. from Little Luckiamute River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NW4, as projected within Musick DLC 58, Section 15, NW4 SE4, as projected within Gilliam DLC 57, Section 16, T. 9 S., R. 5 W., W. M., Little Luckiamute River-620 feet South and 840 feet East from the NW Corner, Section 15; Big Luckiamute River-1410 feet North and 1400 feet West from the SE Corner, Section 16

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and sh

conform to such reasonable rotation system as may be ordered by the proper state officer.
