This Is to Certify, That EAST FORK IRRIGATION DISTRICT

of Hood River, State of Oregon, 97031, has a right to the use of the waters of East Fork Hood River

a tributary of Hood River for the purpose of irrigation of 8,568.2 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Hood River County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 17, at page 333; that the priority of the right thereby confirmed dates from November 25, 1895

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 107.10 cubic feet per second.

The point of diversion is located in the NW 1/4 SW 1/4, Section 4, Township 1 South, Range 10 East, W. M., being 3750 feet south and 430 feet east from the NW corner of Section 4.
