under Permit No. G-5491 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 19, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.19 cubic feet per second, being 0.72 c.f.s. from No. 413 and 0.47 c.f.s. from No. 416

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Lot 10 (SE4 NE4), Section 26; NW4 NE4, Section 35, T. 9 S., R. 4 W., W. M., Well No. 413-710 feet South and 510 feet West from the SW Corner, Wood DLC 55; Well No. 416-470 feet South and 1320 feet West from the NE Corner, Section 35

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,
