## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MELVIN & IRIS HOWELL

of Star Route, Box 300, Forest Grove , State of Oregon, 97116 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Clear Creek provided that the appropriation shall be limited only to those waters originating East of the line running North and South between T. 1 N., R. 5 W., \* a tributary of Gales Creek for the purpose of irrigation of 2.75 acres

under Permit No. 12035 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 27, 1935

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4, Section 17, T. 1 N., R. 4 W., W. M., 1360 feet South and 620 feet East from the NW Corner, Section 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.75 acres SW¼ NW¼ Section 17

T. 1 N., R. 4 W., W. M.

\*W. M. and T. 1 N., R. 4 W., W. M. and shall not include any waters originating West of said line.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered August 2, 1974 and together with special order Volume 24, Page 215 and certificate of water right recorded at Page 47032, Volume 40, State Record of Water Right Certificates, supersedes certificate of water right recorded at Page 14377, Volume 12, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
