CERTIFICATE OF WATER RIGHT

This Is to Certify, That LAKE LABISH WATER CONTROL DISTRICT

of 7816 Lakeside Dr., N.E., Salem , State of Oregon, 97303 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Labish Drainage Ditch

a tributary of Little Pudding River for the purpose of irrigation of 36.8 acres and supplemental irrigation of 10.2 acres

under Permit No. 28870 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 26, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SE4, SE4 SE4; Section 15; NE4 SE4, NW4 SE4, Section 21; NW4 NE4, Section 22, T. 6 S., R. 2 W., W. M.; 2450 feet West and 1330 feet North; 2380 feet West and 1190 feet North; 1300 feet West and 280 feet North; 1920 feet West and 670 feet South; 1980 feet West and 990 feet South, all from the SE Corner, Section 15. 1320 feet North and 230 feet West; *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonalle rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
