CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ROBERT R. DAWSON

of Trail, State of Oregon, 97541, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean
irrigation of 5.3 acres

for the purpose of

under Permit No. 7035 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 19, 1925 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{2}$, Section 3, T. 34 S., R. 1 W., W. M., Tract No. 1-990 feet South and 285 feet West; Tract No. 2-1015 feet South and 405 feet West, both from the NE Corner, Section 3

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 9473, Volume 9, State Record of Water Right Certificates, modified pursuant to the provisions on an order dated April 30, 1963, approving transfer application No. A-31, which was NOT modified by the provisions of orders of the Water Resources Director entered on September 15, 1978, September 28, 1978, and December 13, 1978 approving transfer applications Nos. 3301, 2632, and 2669.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
