that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is lin.ted to an amount actually beneficially used for said purposes, and shall not exceed 0.52 cubic foot per second, being 0.10 c.f.s. from Well No. 1; 0.20 c.f.s. from Well No. 2; and 0.22 c.f.s. from Well No. 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Well No. 1 & 2-SW4 NW4, Section 4, T. 10 S., R. 3 W., W. M., Well No. 3-Lot 4 (SW4 SW4) Section 33, T. 9 S., R. 3 W., W. M.; No. 1-2500 feet South and 860 feet East; No. 2-1530 feet South and 860 feet East, No. 3-30 feet North and 860 feet East, all from the NW Corner, Section 4

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
