## CERTIFICATE OF WATER RIGHT

of Rt. 1, Box 144-A, Independence , State of Oregon, 97351 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Luckiamute River

a tributary of Willamette River for the purpose of irrigation of 53.4 acres and supplemental irrigation of 28.0 acres

under Permit No. 35086 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 2, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.02 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NW4, NE4 SW4 both as projected within Butler DLC 68, Section 34, T. 9 S., R. 4 W., W. M.; No. 1 - 1490 feet North and 270 feet West; No. 2 - 170 feet North and 230 feet West both from SW Corner, Prather DLC 67, Lot 3 (NW4 SE4), Section 3, T. 10 S., R. 4 W., W. M.; No. 3 - 330 feet South and 1240 feet East from C4 Corner, Section 3.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
